EBNMP™ Canada Association continues to support Practitioners of Natural Medicine across Canada. The certification marks / trademarks, DNM®, RAP®, RNP®, RLMP®, RNMP®, under the authority of The World Board of Natural Medicine, are exclusively reserved for our Members in Good Standing, who are listed by name and Province on the website which allows for Insurance companies to verify your billing submissions. This listing is updated quarterly. It is your responsibility to report any person who is using your license without authority.

It time again to renew your membership. For the year 2017, fees remain at \$500.00 for DNM® and \$200.00 for Registered Practitioners and are due by March 30, 2017. This year, all members will receive an individual renewal invoice. If you joined in 2016, you will have a pro-rated fee for your renewal (contact us if in doubt).

To assist our Registrar in these updates and to ensure that your billing is honored, please ensure that your renewal fees are paid on time. Failure to renew on time will result in members being suspended, and listed as suspended as of April 1, 2017 and will remain published, until renewal fees are paid in full. As per EBNMP™ Canada bylaws, Section 14. Membership: "the members in default shall automatically cease to be members of the Corporation. Written notice will be sent to members that have not paid dues informing them of termination of membership".

Cheque or money order** should be payable to EBNMP™ Canada. (NB: Cheques returned by your bank as NSF are subject to an additional fee of \$35.00 and an immediate membership suspension until fees are paid in full). **Payment by credit card:** Visa and Mastercard payments are accepted (additional processing fee of \$10 is applicable). Please complete ALL of the requested information on the back of your 2017 Renewal Form. A separate credit card receipt will also be sent out by mail when the transaction is complete.

We will no longer issue wallet cards and provide yearly stickers, instead members will receive a personalized "Letter of Good Standing and Appreciation".
